

## CONTRACT OF VEHICLE RENTAL

With reference to **32nd TOKYO 2020 OLYMPICS** scheduled on 23 July to 08 August 2021, the HYK Corporation agreed to provide the vehicle requirements of the PHL legislators and their delegation who are official members of the PHL Delegation to the Tokyo Olympics, as follows:

1. HYK Corporation shall provide two (2) vehicles for the PHL legislators and their delegation on their arrival in Tokyo, during their movements while in Tokyo, and their departure from Tokyo. The Philippine Embassy in Tokyo shall provide HYK Corporation the flight details and movements of vehicles as soon as information is confirmed.
2. The contract rate per vehicle is ¥8,800 per hour for a minimum use of 5 hours and a maximum use of 12 hours per day:

**2 vans x ¥8,800/hour x 8 hours/day x 8 days (02 Aug to 09 August 2021) =  
¥1,126,400.00**


After the maximum use of 12 hours, an overtime fee is charged at ¥8,800 per hour, as and when applicable. The contract rate is inclusive of a driver, gasoline, movements of vehicle within Tokyo, and maintenance of the vehicle.

3. Additional charges shall apply for movements of vehicle outside Tokyo, airport-hotel-airport transfers, toll and parking fees for the duration of the rental period, as and when applicable.
4. Payment for rental shall be deposited in full amount to the account of HYK Corporation. All bank charges shall be to the account of the Philippine Embassy:


