BAC RESOLUTION NO. 2025-003

RESOLUTION RECOMMENDING, BY REFERENDUM, THE AWARD OF CONTRACT THROUGH GPPB RESOLUTION NO. 28-2017 FOR THE AWARD TO BELLADWISE INC. (SIGNWEB NETSHOP), FOR THE PROCUREMENT OF A MEDIA WALL FOR THE EMBASSY'S OFFICIAL EVENTS, ENGAGEMENTS AND PROMOTIONAL ACTIVITIES

WHEREAS, the Embassy of the Republic of the Philippines in Japan (Embassy), through its Public Diplomacy Section, implements public diplomacy projects for the promotion of national branding and to facilitate the Embassy's online engagements;

WHEREAS, one of the public diplomacy projects of the Embassy for Fiscal Year (FY) 2025 is the creation of a media wall that can serve as the official backdrop during the Embassy's official events, engagements and promotional activities;

WHEREAS, the procurement of a media wall for the Embassy's official events, engagements and promotional activities, with an Approved Budget for the Contract (ABC) of **One Hundred Fifty Thousand Japanese Yen (JPY150,000.00)** is included in Post's Supplemental Procurement Plan for Fiscal Year 2025, chargeable against the Embassy's General Fund, through its funds for Maintenance and Other Operating Expenses (MOOE);

WHEREAS, under the "*Guidelines for the Procurement of Goods and Services, Infrastructure Projects, and Consulting Services to be Procured and Performed Overseas*," as approved under GPPB Resolution No. 28-2017 dated 31 July 2017, the procurement of any goods, services, infrastructure or consultancy project, regardless of amount, can be conducted by sending out Requests for Quotations (RFQ) to at least three (3) suppliers, contractors or consultants of known qualifications, and receipt of one (1) quotation would be sufficient to recommend award of the project;

WHEREAS, under the same Guidelines, Foreign Service Posts are no longer required to post their procurement activities on the PhilGEPS website until the corresponding facility has become available through the PhilGEPS Modernization Project, and the requirement of advertisement of procurement projects through newspapers have been dispensed with, as well as documentary requirements are relaxed to take into consideration the usual trade and business practices of the host country;

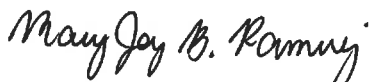
WHEREAS, for the procurement of a media wall for the Embassy's official events, engagements and promotional activities, the Philippine Embassy requested quotations from reputable printing companies, namely BellAdWise Inc. (SignWeb Netshop), the Banner Stand Laboratory and Large Format Print Expert (ObanPrint 110);

WHEREAS, based on the Abstract of Quotations submitted to the Bids and Awards Committee, **BellAdWise Inc. (SignWeb Netshop)** submitted the lowest calculated and responsive bid in the amount of **One Hundred Eighteen Thousand Eight Hundred Japanese Yen (JPY118,800.00)**; while the Banner Stand Laboratory submitted a bid of One Hundred Twenty-Eight Thousand Five Hundred Seventy-Nine Japanese Yen (JPY128,579.00) and Large Format Print Expert (ObanPrint 110) submitted a bid of One Hundred Thirty-Five Thousand Four Hundred Ten Japanese Yen (JPY135,410.00);

NOW, THEREFORE, in light of the foregoing considerations, WE, the Members of the Bids and Awards Committee, hereby RESOLVE to RECOMMEND to the Head of the Procuring Entity (HOPE) of the Philippine Embassy in Tokyo, Japan, to award the contract for the procurement of a media wall for the Embassy's official events, engagements and promotional activities, to **BellAdWise Inc. (SignWeb Netshop)** for the total amount of **One Hundred Eighteen Thousand Eight Hundred Japanese Yen (JPY118,800.00)**, including taxes and other lawful charges.

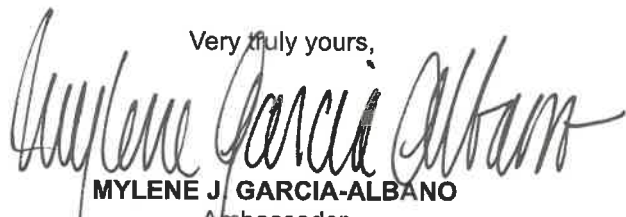
