BAC RESOLUTION NO. 2023-020

RESOLUTION RECOMMENDING, BY REFERENDUM, AWARD OF CONTRACT IN ACCORDANCE WITH THE "GUIDELINES FOR THE PROCUREMENT OF GOODS AND SERVICES, INFRASTRUCTURE PROJECTS, AND CONSULTING SERVICES TO BE PROCURED AND PERFORMED OVERSEAS," AS APPROVED UNDER GPPB RESOLUTION NO. 28-2017 DATED 31 JULY 2017, FOR THE PROCUREMENT OF SERVICES FOR RENOVATION AND INSTALLATION OF NEW APPLIANCES AT THE MASTER KITCHEN (ROOM 115) OF THE OFFICIAL RESIDENCE OF THE AMBASSADOR LOCATED AT 1-1-1 FUJIMI, CHIYODA-KU, TOKYO, AND THE AWARD TO PAE DESIGN AND FACILITY MANAGEMENT FOR THE SAID SERVICES.

WHEREAS, Tokyo PE intends to procure services for the renovation and installation of new appliances at the master kitchen (Room 115) of the Official Residence of the Ambassador located at 1-1-1 Fujimi, Chiyoda-ku, Tokyo;

WHEREAS, the current kitchen at the Official Residence of the Ambassador is outdated and in need of repair. The gas stoves are old and unreliable, the lavatory and dishwasher are showing signs of wear and tear, and the oven is malfunctioning.

WHEREAS, the kitchen has not undergone any repair or construction for almost 20 years, over time it suffers from neglect, wear and tear, and outdated fixtures, leading to damaged fixtures and appliances that compromise its safety and functionality;

WHEREAS, there is a need to renovate the main kitchen (Room 115) and replace the old appliances at the Official Residence of the Ambassador;

WHEREAS, the procurement of the services of a company for the renovation of the kitchen and installation of new appliances with an Approved Budget for the Contract (ABC) of **Nine Million Four Hundred Seventeen Thousand Six Hundred Ninety Two Pesos and Thirty Five Centavos Only (PHP9,417,692.37)** is duly authorized by the Department of Foreign Affairs, chargeable against the Department's Building Fund FY 2023 with ORS No. 011011012023-09-006848 dated 8 September 2023, under facsimile message no. TK-457-OUA-2023 dated 13 September 2023;

WHEREAS, under the "*Guidelines for the Procurement of Goods and Services, Infrastructure Projects, and Consulting Services to be Procured and Performed Overseas*," as approved under GPPB Resolution No. 28-2017 dated 31 July 2017, the procurement of any goods, services, infrastructure or consultancy project, regardless of amount, can be conducted by sending out Requests for Quotations (RFQ) to at least three (3) suppliers, contractors or consultants of known qualifications, and receipt of one (1) quotation would be sufficient to recommend award of the project;

WHEREAS, under the same Guidelines, Foreign Service Posts are no longer required to post their procurement activities on the PhilGEPS website until the corresponding facility has become available through the PhilGEPS Modernization Project, and the requirement of advertisement of procurement projects through newspapers have been dispensed with, as well as documentary requirements are relaxed to take into consideration the usual trade and business practices of the host country;

WHEREAS, for the renovation of the master kitchen at the Official Residence of the Ambassador, the Philippine Embassy requested quotations from reputable companies in Japan, namely Akitem Company, PAE Design and Facility Management and Sakuma Juken Co. Ltd.;

WHEREAS, based on the Abstract of Quotations submitted to the Bids and Awards Committee, PAE Design and Facility Management responded and submitted the lowest and responsive quotation in the amount of **Twenty One Million Eight Hundred Ninety Six Thousand Japanese Yen Only (JPY21,896,000)**;

NOW, THEREFORE, in light of the foregoing considerations, WE, the Members of the Bids and Awards Committee, hereby RESOLVE to RECOMMEND to the Head of the Procuring Entity (HOPE) of the Philippine Embassy in Tokyo, Japan, to resort to the mode of procurement in accordance with the "*Guidelines for the Procurement of Goods and Services, Infrastructure Projects, and Consulting Services to be Procured and Performed Overseas*," as approved under GPPB Resolution No. 28-2017, the renovation and installation of new appliances at the master kitchen (Room 115) of the Official Residence of the Ambassador, through PAE Design and Facility Management in the total amount of **Twenty One Million Eight Hundred Ninety Six Thousand Japanese Yen Only (JPY21,896,000)**, including taxes and other lawful charges, delivery cost and installation charges.




