BAC RESOLUTION NO. 2024-024C

RESOLUTION RECOMMENDING, BY REFERENDUM, TO THE HEAD OF POST OF THE PHILIPPINE EMBASSY IN TOKYO, JAPAN TO RESORT TO NEGOTIATED PROCUREMENT FOR A HIGHLY TECHNICAL CONSULTANT, AS AN ALTERNATIVE METHOD OF PROCUREMENT UNDER R.A. 9184, THE AWARD TO MS. LOIDA OZAKI FOR THE PROCUREMENT OF HER SERVICES AS HIGHLY TECHNICAL CONSULTANT AND CHEF FOR THE EVENT “TASTE OF THE PHILIPPINES”

WHEREAS, the Embassy, through its Cultural Section, in cooperation with the National Commission for Culture and the Arts (NCCA), shall conduct the event “Taste of the Philippines” on 13 November 2024, from 5:30 to 7:00pm, which shall feature dishes from Luzon, Visayas and Mindanao;

WHEREAS, to facilitate the event, the Embassy requires the services of a qualified highly technical consultant and chef with expertise in Philippine cuisine, who is able to prepare a course menu for featuring dishes from Luzon, Visayas and Mindanao, and a dessert featuring Philippine bananas, in line with the Embassy’s efforts to promote Philippine bananas in Japan;

WHEREAS, the procurement for the services of a highly technical consultant for the “Taste of the Philippines” with an Approved Budget for the Contract (ABC) of **Two Hundred Sixty Thousand Japanese Yen Only (JPY260,000.00)**, is included in Post’s Annual Procurement Plan for Fiscal Year 2024, chargeable against the funds provided by the National Commission for Culture and the Arts (NCCA) for the entire project.

WHEREAS, **Ms. Loida Ozaki** is a chef with The New Sanno Hotel in Tokyo, Japan, with a culinary expertise for Philippine cuisine, and is an expert in preparing course menus for Luzon, Visayas and Mindanao, and preparing desserts featuring the Philippine banana;

WHEREAS, Republic Act No. 9184, otherwise known as the *Government Procurement Reform Act* and its Implementing Rules and Regulations prescribe for the modernization, standardization and regularization of the procurement of the government;

WHEREAS, under Sec. 48 of R.A. 9184, any of the Alternative Methods of Procurement may be resorted to, subject to the prior approval of the Head of the Procuring Entity or his duly authorized representative, and whenever justified by the conditions provided in the Act, in order to promote economy and efficiency;

WHEREAS, under Sec. 21.2.1 of the IRR of R.A. 9184, the Procuring Entity may dispense with the advertisement in the newspaper and posting requirement when resorting to alternative methods of procurement;

WHEREAS, under Sec. 53.7 of R.A. 9184, Negotiated Procurement is a method of procurement of Goods, Infrastructure Projects and Consulting services, whereby the Procuring Entity directly negotiates a contract with a technically, legally, and financially capable supplier, contractor or consultant in case of individual consultants hired to do work that is (i) highly technical or proprietary; or (ii) primarily confidential or policy determining, where trust and confidence are the primary consideration for the hiring of the consultant; Provided, however that the term of the individual consultants shall, at the most, be on a six month basis, renewable at the option of the appointing HOPE, but in no case shall exceed the term of the latter;

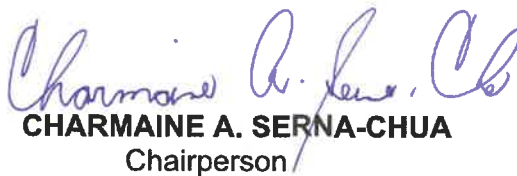
WHEREAS, the services of **Ms. Ozaki** for the event are highly technical or proprietary and fall under Sec.53.7 of R.A. 9184;

WHEREAS, the BAC conducted due diligence inquiries on the selection of **Ms. Ozaki** as a chef for Philippine cuisine and found her to be technically, legally, and financially capable service provider at the most advantageous price and contract for the Government.

WHEREAS, Tokyo PE intends to use the approved budget of **Two Hundred Sixty Thousand Japanese Yen Only (JPY260,000.00)** to procure the services of **Ms. Ozaki** as a highly technical consultant and chef for the event "Taste of the Philippines", chargeable against the funds from the NCCA;

NOW, THEREFORE, in light of the foregoing considerations, **WE**, the Members of the Bids and Awards Committee, hereby **RESOLVE** to **RECOMMEND** to the Head of the Procuring Entity (HOPE) of the Philippine Embassy in Tokyo, Japan, to resort to negotiated procurement for the hiring of a highly technical consultant and chef for the event "Taste of the Philippines", and award of contract, to **Ms. Loida Ozaki, in the total amount of Two Hundred Sixty Thousand Japanese Yen Only (JPY260,000.00)**, including taxes and other lawful charges.
