- k. _____ shall not be supported by or be under the influence of any foreign government or any of its agencies or instrumentalities, or any foreigner, whether natural or juridical person; and
- shall not solicit or receive, directly or indirectly, any contribution or aid of whatever form or nature from any foreign government or any of its agencies or instrumentalities, or any foreigner, whether natural or juridical person.
