BAC RESOLUTION NO. 2024-015

RESOLUTION RECOMMENDING, BY REFERENDUM, TO THE HEAD OF POST OF THE PHILIPPINE EMBASSY IN TOKYO, JAPAN TO RESORT TO THE MODE OF PROCUREMENT UNDER GPPB RESOLUTION NO. 28-2017 DATED 31 JULY 2017, AND THE AWARD TO GOOD CHRISTIAN ENSEMBLE AS PERFORMERS FOR THE PHILIPPINE INDEPENDENCE DAY RECEPTION TO BE HELD ON 12 JUNE 2024

WHEREAS, in view of the 126th Philippine Independence Day on 12 June 2024, the Philippine Embassy in Tokyo will hold a National Day Reception on the said date;

WHEREAS, Ambassador Mylene Garcia-Albano will welcome approximately four hundred (400) Japanese government officials, members of the Diplomatic Corps and representatives of the business sector, the academe, and the media;

WHEREAS, Post intends to engage the services of performers who can represent the Philippines' history and culture with accompanying music, props and costumes during the Reception;

WHEREAS, the planning and contracting of said performers is under Cultural Activities for the Philippine Independence Day Celebration which is included in the Procuring Entity's Annual Procurement Plan and Procurement Management Plan (PPMP) of Cultural Section;

WHEREAS, it intends to use the approved budget of **Two Hundred Seventy Thousand Japanese Yen (JPY270,000)**, chargeable against Post's MOOE;

WHEREAS, Republic Act No. 9184, otherwise known as the *Government Procurement Reform Act* and its Implementing Rules and Regulations prescribe for the modernization, standardization and regularization of the procurement of the government;

WHEREAS, CIR-397-BAC-2018 dated 15 February 2018 and CIR-2354-OUA-2019 dated 15 October 2019 provided GPPB Resolution No. 28-2017 dated 31 July 2017, prescribing guidelines for overseas procurement of goods and services, infrastructure and consulting services;

WHEREAS, under the same resolution, Foreign Service Posts will not be required to post their procurement activities in the PHILGEPS website until the corresponding facility has become available through the PhilGEPS Modernization Project, the requirement of advertisement of procurement projects through newspapers was dispensed, as well as

documentary requirements are relaxed to take into consideration the usual trade and business practices of the host country;

WHEREAS, under the GPPB Resolution No. 28-2017, procurement of any goods, services, infrastructure or consultancy project, regardless of amount, can be conducted by sending out three (3) requests for quotations (RFQ) to at least three suppliers, contractors or consultants of known qualifications, and receipt of one (1) quotation would be sufficient to recommend award of the project;

WHEREAS, for the procurement of the services of the performers for the Reception in commemoration of 126th Philippine Independence Day on 12 June 2024 to be held at a hotel in Tokyo, the Philippine Embassy requested quotations from three (3) service providers, namely, Koristas, Good Christian (GC) Ensemble, and UP Manila Chorale;


WHEREAS, based on the Abstract of Quotations submitted to the Bids and Awards Committee, **only Good Christian Ensemble responded and submitted the lowest and responsive quotation in the amount of Two Hundred Sixty Three Thousand Japanese Yen (JPY263,000);**

WHEREAS, the BAC conducted due diligence inquiries on the submission of Good Christian Ensemble and found that its quotation is responsive to BAC's RFQ and that the company is found to be technically, legally, and financially capable supplier;

NOW, THEREFORE, in light of the foregoing considerations, WE, the Members of the Bids and Awards Committee, hereby **RESOLVE to:**

NOW, THEREFORE, in light of the foregoing considerations, WE, the Members of the Bids and Awards Committee, hereby **RESOLVE to RECOMMEND** to the Head of the Procuring Entity (HOPE) of the Philippine Embassy in Tokyo, Japan, to resort to the mode of procurement in accordance with the "*Guidelines for the Procurement of Goods and Services, Infrastructure Projects, and Consulting Services to be Procured and Performed Overseas,*" as approved under GPPB Resolution No. 28-2017, and **award of contract to Good Christian Ensemble as performers for Post's Reception in commemoration of the Philippine Independence Day on 12 June 2024, for the total amount of Two Hundred Sixty Three Thousand Japanese Yen (JPY263,000).**


