BAC RESOLUTION NO. 2024-043

RESOLUTION RECOMMENDING, BY REFERENDUM, THE AWARD OF CONTRACT THROUGH GPPB RESOLUTION NO. 28-2017 FOR THE AWARD TO FUJI-KIGYO CORPORATION FOR THE PROCUREMENT OF GO BAGS AND PREPARATIONS UNDERTAKEN FOR DISASTER PREPAREDNESS

WHEREAS, the Embassy requires services of a qualified contractor capable of providing emergency bags for disaster situations containing basic survival supplies, otherwise known as "Go Bags", and basic survival necessities for storing, otherwise known as "stockpile sets", for the official use of the Embassy's personnel and visitors/clients in the event of a disaster, hereinafter referred to as the "Project;"

WHEREAS, the procurement of Go Bags and Stockpile Sets for the Embassy, with an Approved Budget for the Contract (ABC) of **One Million Japanese Yen (JPY1,000,000.00)** is included in Post's Annual Procurement Plan for Fiscal Year 2024, chargeable against the Embassy's General Fund – Maintenance and Other Operating Expenses (MOOE);

WHEREAS, under the *"Guidelines for the Procurement of Goods and Services, Infrastructure Projects, and Consulting Services to be Procured and Performed Overseas,"* as approved under GPPB Resolution No. 28-2017 dated 31 July 2017, the procurement of any goods, services, infrastructure or consultancy project, regardless of amount, can be conducted by sending out Requests for Quotations (RFQ) to at least three (3) suppliers, contractors or consultants of known qualifications, and receipt of one (1) quotation would be sufficient to recommend award of the project;

WHEREAS, under the same Guidelines, Foreign Service Posts are no longer required to post their procurement activities on the PhilGEPS website until the corresponding facility has become available through the PhilGEPS Modernization Project, and the requirement of advertisement of procurement projects through newspapers have been dispensed with, as well as documentary requirements are relaxed to take into consideration the usual trade and business practices of the host country;

WHEREAS, for the procurement of Go Bags and Stockpile Sets as part of the Philippine Embassy's preparations for its contingency planning measures in case of disasters, the Philippine Embassy requested quotations from reputable sales and manufacturing companies, namely Fuji-Kigyo Corporation, Offix Co. Ltd. and La Pita;

WHEREAS, based on the Abstract of Quotations submitted to the Bids and Awards Committee, **Fuji-Kigyo Corporation** submitted the **lowest calculated and responsive bid** in the amount of about **Seven Hundred Thirty-Six Thousand Ninety-Six Japanese Yen (JPY736,096.00)**; **Offix Co. Ltd.** submitted a quotation of **Six Hundred Forty-Seven Thousand Eight Hundred Japanese Yen (JPY647,800.00)**, however, the quotation was not responsive to the technical specifications of the Request for Quotation as the price does not include the complete required items for the Go Bag, and does not cover any stockpile sets; while **La Pita** submitted a quotation of **One Million Five Hundred Thirty-Eight Thousand One Hundred Thirty Japanese Yen (JPY1,538,130.00)** which is above the ABC;

NOW, THEREFORE, in light of the foregoing considerations, **WE**, the Members of the Bids and Awards Committee, hereby **RESOLVE** to **RECOMMEND** to the Head of the Procuring Entity (**HOPE**) of the Philippine Embassy in Tokyo, Japan, to award the contract for the procurement of Go Bags and preparations undertaken for disaster preparedness, to **Fuji-Kigyo Corporation** for the total amount of **Seven Hundred Thirty-Six Thousand Ninety-Six Japanese Yen (JPY736,096.00)**, including taxes and other lawful charges.
