BAC RESOLUTION NO. 2024-024

RESOLUTION RECOMMENDING, BY REFERENDUM, THE AWARD OF CONTRACT THROUGH GPPB RESOLUTION NO. 28-2017 FOR THE PROVISION OF DECORATIVE SERVICES FOR THE DIPLOMATIC RECEPTION FOR NON-RESIDENT AMBASSADORS FOR THE PHILIPPINES' BID FOR THE UNITED NATIONS SECURITY COUNCIL FOR THE TERM 2027-2028 AT THE OFFICIAL RESIDENCE OF THE AMBASSADOR

WHEREAS, the Philippine Embassy in Tokyo, through its Political Section, is in charge of overseeing the projects on the Philippines' bid for the United Nations Security Council for the Term 2027-2028;

WHEREAS, Tokyo PE has decided to host a diplomatic reception for Non-Resident Ambassadors (NRAs) to the Philippines on 04 October 2024 in order to reach this goal;

WHEREAS, the diplomatic reception will provide a unique opportunity for diplomats to gather in a relaxed setting, facilitating conversations centered on strengthening partnerships and deepening cooperation across key multilateral platforms, including the United Nations;

WHEREAS, the procurement of the decorative services for the diplomatic reception with an Approved Budget for the Contract (ABC) of **Five Hundred Fifty Thousand Japanese Yen (¥550,000)** is included in Post's Annual Procurement Plan for 2024, chargeable against its Representation Expenses for FY 2024.

WHEREAS, under the GPPB Resolution No. 28-2017, the procurement of any goods, services, infrastructure or consultancy project, regardless of cost, can be conducted by sending out three (3) requests for quotations (RFQ) to at least three suppliers, contractors or consultants of known qualifications, and receipt of one (1) quotation would be sufficient to recommend award of the project;

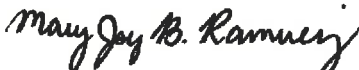
WHEREAS, for the procurement for the provision of decorative services for the diplomatic reception for Non-Resident Ambassadors, Tokyo PE requested quotations from three (3) service providers, namely, Nikkei Sangyo Kokokusha Inc., Sanno Space & Rental and Event21 Co. Ltd.;

WHEREAS, only Nikkei Sangyo Kokokusha Inc. responded and submitted the lowest calculated and responsive quotation of **Two Hundred Fourteen Thousand Six Hundred Japanese Yen (¥214,600)**;

NOW, THEREFORE, in light of the foregoing considerations, **WE**, the Members of the Bids and Awards Committee, hereby **RESOLVE** to **RECOMMEND** to the Head of the Procuring Entity (HOPE) of the Philippine Embassy in Tokyo, Japan, to resort to the mode of procurement provided by GPPB Resolution No. 28-2017 dated 31 July 2017, and award the contract on the provision of decorative services for the diplomatic reception for Non-Resident Ambassadors for the Philippines' bid for the United Nations Security Council for the term 2027-2028 at the Official Residence of the Ambassador, for the total amount of Two Hundred Fourteen Thousand Six Hundred Japanese Yen (¥214,600), inclusive of taxes and other lawful charges, to Nikkei Sangyo Kokokusha Inc.
