- Directly release the full amount to Young Voices of the Philippines within 15 working days after implementation of activity. This is subject to Young Voices of the Philippines' fulfillment of the conditions stated below.
- Cover for all applicable bank charges and wire transfer fees. Bank charges and transfer fees will not be deducted from the total amount of budget stipulated in this Agreement; and
- Send a proof of deposit/remittance of the payment to the artist

The Young Voices of the Philippines, herein represented by Dr. Maria Theresa Vizconde-Roldan, as lead proponent, shall:

- Submit the final and approved version of the video no later than 9:00 A.M. of 19 August 2021. A first draft of the video will be submitted to the Philippine Embassy for review on 17 August 2021.
- Fully acknowledge Tokyo PE in all media releases, promotional materials, etc. related to the video. In all relevant social media posts, include and use the hashtags: #KulturaPH #SentroRizalTokyo;
- Accomplish and submit to Tokyo PE the Video Consent Release Form (attached);
- For processing of payment, submit the following information and documents to Tokyo PE within 15 working days after implementation of activity:
 - a. Tax Identification Number;
 - b. Photocopy of bank account (passbook or ATM) or bank details necessary for remittance
 - c. Signed Letter of Agreement;
 - d. Signed Video Consent Form
