BAC RESOLUTION NO. 2022-016B

RESOLUTION RECOMMENDING, BY REFERENDUM, AWARD OF CONTRACT IN ACCORDANCE WITH THE "GUIDELINES FOR THE PROCUREMENT OF GOODS AND SERVICES, INFRASTRUCTURE PROJECTS, AND CONSULTING SERVICES TO BE PROCURED AND PERFORMED OVERSEAS," AS APPROVED UNDER GPPB RESOLUTION NO. 28-2017 DATED 31 JULY 2017, FOR THE PROCUREMENT OF THE RENOVATION OF THE FAMILY KITCHEN AT THE OFFICIAL RESIDENCE OF THE AMBASSADOR

WHEREAS, Post intends to procure the services of a company for the renovation of the family kitchen on the second floor of the Official Residence of the Ambassador located at 1-1-1 Fujimi, Chiyoda-ku, Tokyo, Japan.

WHEREAS, there is a need to renovate the family kitchen of the Official Residence since the equipment/appliances and fixtures in this essential area are either unserviceable or outmoded and overused.

WHEREAS, the procurement of the services of a company for the repair and/or replacement of equipment with an Approved Budget for the Contract (ABC) of One Million Three Hundred Seventy Eight Thousand Five Hundred Seventeen Philippine Pesos and Thirteen Centavos (PHP1,378,517.13) is duly authorized by the Department of Foreign Affairs, chargeable against the Department's Building Fund FY 2021 Continuing Appropriations with ORS No. 2022-10-000915 dated 18 October 2022, under facsimile message no. TK-1191-OUA-2022 dated 19 October 2022;

WHEREAS, under the "Guidelines for the Procurement of Goods and Services, Infrastructure Projects, and Consulting Services to be Procured and Performed Overseas," as approved under GPPB Resolution No. 28-2017 dated 31 July 2017, the procurement of any goods, services, infrastructure or consultancy project, regardless of amount, can be conducted by sending out Requests for Quotations (RFQ) to at least three (3) suppliers, contractors or consultants of known qualifications, and receipt of one (1) quotation would be sufficient to recommend award of the project;

WHEREAS, under the same Guidelines, Foreign Service Posts are no longer required to post their procurement activities on the PhilGEPS website until the corresponding facility has become available through the PhilGEPS Modernization Project, and the requirement of advertisement of procurement projects through newspapers have been dispensed with, as well as documentary requirements are relaxed to take into consideration the usual trade and business practices of the host country; WHEREAS, for the renovation of the family kitchen at the Official Residence of the Ambassador, the Philippine Embassy requested quotations from reputable companies in Japan namely Aircon Plant Industries Co. Ltd., BB. Kensou Co. Ltd. and Akitem Company Ltd.;

WHEREAS, based on the Abstract of Quotations submitted to the Bids and Awards Committee, Akitem Company Ltd. responded and submitted the lowest and responsive quotation;

NOW, THEREFORE, in light of the foregoing considerations, WE, the Members of the Bids and Awards Committee, hereby RESOLVE to RECOMMEND to the Head of the Procuring Entity (HOPE) of the Philippine Embassy in Tokyo, Japan, to resort to the mode of procurement in accordance with the "Guidelines for the Procurement of Goods and Services, Infrastructure Projects, and Consulting Services to be Procured and Performed Overseas," as approved under GPPB Resolution No. 28-2017, for the renovation of the family kitchen of the Official Residence of the Ambassador, through Akitem Company Ltd. in the total amount of **Three Million Four Hundred Thousand Japanese Yen (JPY3,400,000)**, including taxes and other lawful charges, delivery cost and installation charges.
