The Embassy of the Republic of the Philippines in Tokyo, Japan (Embassy), through the authorized appropriations in the Fiscal Year (FY) 2024 General Appropriations Act (GAA), chargeable against the Embassy's General Fund through its funds for Maintenance and Other Operating Expenses (MOOE), intends to apply the sum of **Fifteen Million Philippine Pesos (PHP15,000,000.00)**, being the Approved Budget for the Contract (ABC) for the procurement of consultancy services for the Kudan Redevelopment Project.

Quotations/Proposals received in excess of the ABC shall be automatically rejected.

ANNEX A

TERMS OF REFERENCE

The Embassy of the Republic of the Philippines in Tokyo, Japan intends to secure the services of a qualified architectural firm which is capable of providing consultancy services for the Kudan Redevelopment Project (Project).

I. Description

The Embassy requires services of a qualified architectural firm which is capable of providing consultancy services for the Project. The consultant must have design, project scheduling and surveying experience that will provide design inputs, design review and surveying services for the redevelopment of the Kudan, so that a shovel-ready plan can be formulated to enable the Embassy to apply for a Multi-Year Contractual Authority for FY 2025 onwards. The firm must be able to preserve the main design elements of the property, in line with its status as a National Historical Landmark, while ensuring that the property has seismic structural integrity. The firm must also integrate Philippine design elements into the Project.

II. Approved Budget for the Contract

The approved Budget for the Contract (ABC) for the Project shall not exceed **Thirty-Nine Million Five Hundred Thousand Japanese Yen (JPY39,500,000.00)**.

III. Deliverables

The Kudan Redevelopment Project shall be awarded to a qualified architectural consultancy firm, with the following specifications and inclusions:

- A. Plans for the renovation and retrofitting work for the Main Residence Building:
 - Non-structural repairs and renovation of the entire area;
 - Basement renovation that would include ascertaining that carbon monoxide and other harmful chemicals are not present in the area;
 - Electrical, lighting and plumbing work (including upgrading of pipework);
 - Interior design and finishing works;
 - Plans for mold and mildew removal, and pest control work; and
 - Improvement of ventilation and modernization.
- B. Designs for a multi-floor and multi-purpose Annex Building with installation of furniture and furnishings in the multi-purpose rooms and a restaurant-grade kitchen;
- C. Plan and design for a separate driveway for guests of the Annex Building;
- D. Plan for the renovation of cascading fountain, fishpond and Japanese shrine re-location, mindful of religious considerations on the latter;
- E. Plan for the landscaping of the entire gardens and plans on how to conceal the Chauffeur's Residence;
- F. Conformity of redevelopment plan with Japanese building regulations/ codes, Fire Safety and specifically the area where the Kudan is located, in light of PAE's recommendations under the 2023 Final Report for the Kudan's Seismic Structural Analysis prepared by PAE Design and Facility Management;

- G. Incorporation of Philippine elements in the redevelopment plan and proposed designs;
- H. Incorporation of "green architecture" or environment-friendly and efficient renovation and construction processes and materials in the design and architectural process; and
- I. Plan and design for other additional renovation and redevelopment work, as seen fit during the project period.

IV. Pricing

The cost of the product/service shall be quoted in Japanese yen, inclusive of all taxes and other lawful charges.

V. Evaluation Process

The Project shall be awarded to the lowest priced, acceptable, and responsive quotation/offer.

The Philippine Embassy reserves the right to accept or reject any quotation, and to reject all quotations at any time prior to award of contract, without incurring any liability to the affected company/supplier.

VI. Terms of Payment

Payment shall be made after the complete delivery and inspection of the materials and work and upon receipt of the invoice by the Finance Section of the Philippine Embassy.
