TERMS OF REFERENCE

The Embassy of the Republic of the Philippines in Tokyo, Japan intends to secure the services of a qualified company which can the lease of additional aroma diffusers for the Embassy Chancery to address the mold and mildew scents permeating in the Embassy Chancery due to the old age of the building.

I. Description

Procurement for the lease of additional aroma diffusers for the Embassy Chancery to address the mold and mildew scents permeating in the Embassy Chancery due to the old age of the building.

II. Approved Budget for the Contract

The approved Budget for the Contract (ABC) for the Project shall not exceed **Five Hundred Thousand Yen (JPY500,000)**.

III. Deliverables

The company/supplier shall be a qualified service provider / company that is capable of leasing aroma diffusers for the Philippine Embassy Chancery's Multi-Purpose Hall (Siazon Hall) and the hallways of the Ambassador's and the Deputy Chief of Mission's offices, with the following specifications and inclusions:

- A) Annual lease of aroma diffusers with the minimum coverage area of twenty (20) tatami mats or 36m2;
- B) Initial installation included in project cost;
- C) Monthly maintenance of aroma diffuser units;
- D) Waste disposal for any waste materials during installation; and
- E) Transportation and installation charges.

IV. Pricing

The cost of the product/service shall be quoted in Japanese yen, inclusive of all taxes and other lawful charges (including delivery).

V. Evaluation Process

The Project shall be awarded to the lowest priced, acceptable, and responsive quotation/offer.
