TERMS OF REFERENCE

The Embassy of the Republic of the Philippines in Tokyo, Japan intends to secure the services of a qualified company which can provide services procurement for the lease of display cabinets and sets, for the event on Philippine Heritage Jewelry, to be held on 15 November 2024.

I. <u>Description</u>

Procurement for the lease of display cabinets and sets, for the event on Philippine Heritage Jewelry, to be held on 15 November 2024.

II. Approved Budget for the Contract

The approved Budget for the Contract (ABC) for the Project shall not exceed **One Hundred Five Thousand Philippine Pesos (PHP105,000) or around Two Hundred Ninety Thousand Eight Hundred Japanese Yen (JPY290,800).**

III. Deliverables

The company/supplier shall be a qualified service provider / company that is capable of leasing equipment for the event on Philippine Heritage Jewelry, with the following specifications and inclusions:

- A) The leased items are display cabinets and display sets for fine jewelry;
- B) One cabinet shall have a landscape orientation;
- C) One cabinet shall have a portrait orientation;
- D) The display set shall be black, preferably with velvet lining or cushioning;
- E) The lease of items should include the shipment and delivery of the leased items.

IV. Pricing

The cost of the product/service shall be quoted in Japanese yen, inclusive of all taxes and other lawful charges (including delivery).

V. Evaluation Process

The Project shall be awarded to the lowest priced, acceptable, and responsive quotation/offer.
