#### TERMS OF REFERENCE

- c. Philippine Delegation Visits Japan Hydrographic and Oceanographic Department Survey Vessel Hamashio, 22 March 2024

#### I. Description

Lease of vehicle, with driver, for the delegations who are on official trip to Japan in March 2024.
