TERMS OF REFERENCE

The Embassy of the Republic of the Philippines in Tokyo, Japan intends to secure the services of a qualified transportation company/service provider which can provide the procurement for the lease of vehicles for the event "Philippine Christmas Concert 2024".

I. Description

Procurement for the lease of vehicles for the event "Philippine Christmas Concert 2024", for the service period of 8 to 13 December 2024.

II. Approved Budget for the Contract

The approved Budget for the Contract (ABC) for the Project shall not exceed **Five Hundred Thousand Philippine Pesos (PHP500,000.00) or around One Million Three Hundred Eighty-Five Thousand Japanese Yen** (JPY1,385,000.00).

III. Deliverables

The company/supplier shall be a qualified service provider / transportation company that is capable of leasing vehicles to the Embassy for the event "Philippine Christmas Concert 2024" with the following specifications and inclusions:

- A) The transportation routes and schedules shall be as follows:
 - i) <u>8 Dec</u> Narita Airport at 5:00a.m., arrival of University of Santo Tomas (UST) Singers; inside Tokyo, rent up to 6:00p.m.;
 - ii) <u>11 Dec</u> event date, inside Tokyo from 9:00a.m to 6:00p.m.;
 - iii) <u>13 Dec</u> Departure of UST Singers, inside Tokyo hotel to Narita Airport from 11:30a.m. onwards;
 - iv) <u>9 Dec</u> Narita Airport at 2:10p.m. to Tokyo, arrival of Mandaluyong Children's Choir;
 - v) <u>11 Dec</u> 9:00a.m. to 9:00p.m. for Event Day;
 - vi) <u>13 Dec</u> 11:30a.m. Tokyo to Narita Airport, departure of Mandaluyong Children's Choir.
- B) Price should include the toll fees for the routes to be taken and fuel refilling;
- C) Company/supplier shall provide its own licensed drivers for the vehicles;
- D) Vehicles shall be roadworthy and capable of performing the routes and schedules specified; and
- E) Company/supplier should provide vehicles capable of accommodating at least 20 passengers per vehicle.

IV. Pricing

The cost of the product/service shall be quoted in Japanese yen, inclusive of all taxes and other lawful charges (including delivery).

V. Evaluation Process

The Project shall be awarded to the lowest priced, acceptable, and responsive quotation/offer.

The Philippine Embassy reserves the right to accept or reject any quotation, and to reject all quotations at any time prior to award of contract, without incurring any liability to the affected company/supplier.

VI. Terms of Payment

Payment shall be made after the complete delivery and inspection of the materials and work and upon receipt of the invoice by the Finance Section of the Philippine Embassy.
