#### **TERMS OF REFERENCE**

The Embassy of the Republic of the Philippines in Tokyo, Japan intends to secure the services of a qualified construction company for the Reinforcement of the Perimeter Fence at the Philippine Government Property located at 11-24 Nanpeidai, Shibuya City, Tokyo 150-0036, on 22 July 2024.

### I. Description

The Embassy needs the services of a qualified construction company for the Reinforcement of the Perimeter Fence at the Philippine Government Property located at 11-24 Nanpeidai, Shibuya City, Tokyo 150-0036, on 22 July 2024.

# II. Approved Budget for the Contract

The approved Budget for the Contract (ABC) for the Project shall not exceed **Two** Million Five Hundred Forty-One Thousand One Hundred Fifty-Seven Pesos and Eight Centavos (PHP2,541,157.08) or Six Million Eight Hundred Thirty-Five Thousand Seven Hundred Twelve Yen (JPY6,835,712)

#### III. Deliverables

The company/supplier shall be a qualified construction company licensed to conduct business and engage in construction services in Japan, which shall be required to comply with the following deliverables:

- A) Take note of the identified perimeter fence area for renovation with starting mark from the right side of the property line ending at the back garden area.
- B) Uprooting of plants and trees in the identified area which impair the structural integrity of the fence;
- C) Leveling of the land after the uprooting activities:
- D) Raising of the manhole next to the perimeter fence:
- E) Placement of reinforcement bars and base stopping framework;
- F) Base concrete pouring and curing;
- G) Clearing up of debris, felled trees and uprooted plants;
- H) Proper and complete waste disposal for the whole project;
- I) Installation of a frame in front of the power distribution box located along the perimeter fence area:
- J) Coordination with the Tokyo Power Grid to ensure compliance with any domestic regulations of Japan for electric and gas lines; and
- K) Ensure compliance with domestic requirements for civil engineering works in Japan.

## IV. Pricing

The cost of the product/service shall be quoted in Japanese yen, inclusive of all taxes and other lawful charges (including delivery).
