TERMS OF REFERENCE

The Embassy of the Republic of the Philippines in Tokyo, Japan intends to secure the services of a qualified construction company for the procurement for the Installation of Additional Electrical Outlets at the Pond Area of the Inner Garden and Repair of Lights for Room 209 at the Official Residence, for the service period of July 2024 onwards.

I. Description

Procurement for the Installation of Additional Electrical Outlets at the Pond Area of the Inner Garden and Repair of Lights for Room 209 at the Official Residence, for the service period of July 2024 onwards

II. Approved Budget for the Contract

The approved Budget for the Contract (ABC) for the Project shall not exceed **Six Hundred Thousand Japanese Yen Only (JPY600,000.00).**

III. Deliverables

The company/supplier shall be a qualified service provider / company that is capable of providing the installation of electrical outlets, with the following specifications and inclusions:

- A) The electrical outlets shall be for the installation of capiz lights at the trees and shrubbery at the pond area of the inner garden of the Official Residence of the Ambassador;
- B) The outlets must be capable of plugging in Philippine devices and lights (220V) or Japanese devices (100V);
- C) The repair of the lights at room 209 at the Main Residence shall be included;
- D) The installed outlets must be safe from the elements;
- E) The company/supplier must provide its own workers for the job;
- F) The company/supplier must provide a point person or site manager who shall oversee the installation and coordinate with the Embassy as needed;
- G) The company/supplier must handle the proper disposal of all waste items generated from performing the work; and
- H) The company/supplier must take care not to cause any damage or permanent alterations to the inner garden and all areas of the Official Residence, in light of its status as a National Historical Landmark.

IV. Pricing

The cost of the product/service shall be quoted in Japanese yen, inclusive of all taxes and other lawful charges (including delivery).

V. Evaluation Process

The Project shall be awarded to the lowest priced, acceptable, and responsive quotation/offer.

The Philippine Embassy reserves the right to accept or reject any quotation, and to reject all quotations at any time prior to award of contract, without incurring any liability to the affected company/supplier.

VI. Terms of Payment

Payment shall be made after the complete delivery and inspection of the materials and work and upon receipt of the invoice by the Finance Section of the Philippine Embassy.
