# ANNEX A

## **TERMS OF REFERENCE**

The Embassy of the Republic of the Philippines in Tokyo, Japan intends to secure the services of a qualified company which can provide the repair of the main entrance doors at the Official Residence of the Ambassador, for the service period of November 2024.

## I. Description

Procurement for the repair of the main entrance doors at the Official Residence of the Ambassador, for the service period of November 2024.

# II. Approved Budget for the Contract

The approved Budget for the Contract (ABC) for the Project shall not exceed **Three Hundred Thousand Japanese Yen (JPY300,000.00)**.

## III. Deliverables

The company/supplier shall be a qualified service provider / company that is capable of providing repair services for the Embassy with the following specifications and inclusions:

- A) Maintain the original appearance of the main entrance doors and guarantee its form and functionality even after the completion of the repair service, in line with the status of the Official Residence of the Ambassador as a National Historical Landmark;
- B) Provide an initial inspection and assessment of the main entrance doors;
- C) Maintain the original accessories of the main entrance doors if this is not possible, provide accessory parts which are identical or nearly identical to the originals, and to return the originals to the Embassy after the completion of the repair service;
- D) Verify why only the right-hand side of the main entrance doors (as opened from within) can be fully opened, while the left-hand side of the entrance doors can only be opened halfway;
- E) Enable the full opening of both the right-hand and left-hand doors;
- F) Provide the necessary supervisor and personnel for the project;
- G) Maintain the work area free from any lasting alterations or damages;
- H) Warrant to the Embassy that all materials and equipment incorporated in the work shall be free of good quality and free from any faults or defects; and
- I) Dispose of any and all waste materials generated from the project.

### IV. Pricing

The cost of the product/service shall be quoted in Japanese yen, inclusive of all taxes and other lawful charges (including delivery).

### V. Evaluation Process

The Project shall be awarded to the lowest priced, acceptable, and responsive quotation/offer.

The Philippine Embassy reserves the right to accept or reject any quotation, and to reject all quotations at any time prior to award of contract, without incurring any liability to the affected company/supplier.

## VI. Terms of Payment

Payment shall be made after the complete delivery and inspection of the materials and work and upon receipt of the invoice by the Finance Section of the Philippine Embassy.
